**EARNESTLY REQUESTING THE LOCAL CHIEF EXECUTIVE,
HON. JANET DE LEON-MERCADO, TO ALLOCATE FUNDS
IN THE AMOUNT OF TWO MILLION ONE HUNDRED FIFTY
EIGHT THOUSAND THREE HUNDRED THIRTY EIGHT
PESOS AND SEVEN CENTAVOS (PHP 2,158,338.07) FOR THE
COMPLETE REHABILITATION OF LIWAYWAY DRIVE, BARANGAY DOLORES,
TAYTAY, RIZAL TO BE CHARGED UNDER THE 20% DEVELOPMENT FUND FOR
THE YEAR 2014, THIS MUNICIPALITY**

WHEREAS, the Local Government Unit shall endeavor to be self-reliant and shall establish infrastructure facilities intended to service the needs of its residents including, but not limited to concreting of municipal roads;

WHEREAS, residents of Blooming Hills Subdivision, Barangay Dolores, have since 2004, requested for the concreting and improvement of roads in their area to the Municipal Government of Taytay and Provincial Government of Rizal;

WHEREAS, the Provincial Government of Rizal, recognizing that basic infrastructure and facilities such as concreting of roads spur economic growth and sustainable development in the area, funded and concreted Carnation Street and a portion of Sampaguita Street, Blooming Hills Subdivision, Barangay Dolores in 2008 and 2011, respectively;

WHEREAS, on February 13, 2012, the Provincial Government of Rizal requested the Local Government of Rizal requested the Local Government of Taytay's initiative for possible completion or concreting of the remaining projects, including Liwayway Drive, to complement the improvements already done by them;

WHEREAS, rehabilitation of Liwayway Drive, Blooming Hills Subdivision would require a total amount of Two Million One Hundred Fifty Eight Thousand Three Hundred Thirty Eight Pesos and Seven Centavos (PHP 2,158,338.07);


WHEREAS, in as much as the rehabilitation of Liwayway Drive, Blooming Hills Subdivision would involve a substantial amount, implementation can be in three (3) phases and funding can be sourced through the 20% Development Fund for the year 2014, this municipality;

WHEREFORE, BE IT RESOLVED, as it is hereby resolved by the 9th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby requests the Local Chief Executive, Hon. Janet de Leon-Mercado, to allocate funds in the amount of Two Million One Hundred Fifty Eight Thousand Three Hundred Thirty Eight Pesos and Seven Centavos (PHP 2,158,338.07) for the complete Rehabilitation of Liwayway Drive, Barangay Dolores, Taytay, Rizal to be charged under the 20% Development Fund for the year 2014, this municipality;


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action;
