FOR THE GOVERNMENT EMPLOYEES RESIDENTIAL
CONDOMINIUM PROGRAM**

WHEREAS, section 444 (b) (1) (vi) Republic Act 7160 also known as Local Government Code of 1991 (a) Municipal Mayor as Chief Executive of the Municipal Government shall exercise such powers and duties and functions as provided by this code and other laws;

WHEREAS, with the resemblance to the resolution passed by the Sangguniang Bayan last November 29 series of 2012, apparently with different set of beneficiary likewise concerning to a socialized housing project;

WHEREAS, in line with the vision of the Local Government Unit to stimulate, assist, acquire home and provide shelter among Municipality of Taytay Employees by promoting homeownership through Socialized Housing Program;

WHEREAS, to cope up with various Local Government Unit that has gone to the process of implementing the Socialized Housing Project among Government Employees;

WHEREAS, Memorandum of Agreement should be ratified before its full implementation of the project;

NOW THEREFORE RESOLVED, as it is hereby resolved by the Sangguniang Bayan duly assembled in session hereby authorizes the Municipal Mayor Honorable George Ricardo R. Gacula II to negotiate in behalf of the Municipal Government of Taytay with any person/s or entity/ies for the Government Employees Residential Condominium Program;
