RESOLUTION NO. 180

**AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A
MEMORANDUM OF UNDERTAKING BETWEEN THE MUNICIPALITY
OF TAYTAY, RIZAL AND THE DEPARTMENT OF PUBLIC WORKS
AND HIGHWAY (DPWH) FOR THE IMPROVEMENT/CONSTRUCTION
OF KAYTIKLING JUNCTION (ROTONDA)**

WHEREAS, the Department of Public Works and Highway (DPWH) is implementing an on-going projects for the road construction of geometric widening/improvement of the Ortigas Avenue Extension – BF Metal Corporation to Cainta Junction, affecting several private properties adjoining the said Ortigas Avenue Extension located within the Municipality of Taytay;

WHEREAS, in order to acquire the Right of Way of portions of private properties affected by road widening/improvement/construction of Kaytikling Junction by the Department of Public Works and Highway (DPWH) the Local Chief Executive should enter into a Memorandum of Undertaking with said agency;

WHEREAS, in the acquisition of the above-mentioned Right of Way and in the interest of and pursuit of progress and development for the municipalities affected and the entire Province of Rizal as a whole, the Municipal Government of Taytay the Provincial Government of Rizal, and the Municipal Government of Cainta, have committed, as part of their development plans for the municipalities affected and the Province of Rizal, to provide funds for the payment to the owners of the private properties affected by the Road Widening/Improvement Project;

WHEREAS, it is deemed proper that a resolution be passed authorizing the Local Chief Executive to enter into Memorandum of Undertaking to expedite the implementation of the said project;


