WHEREAS, at present the Taytay Public Cemetery is already congested and the apartment type of tomb already exceeds its limit;



WHEREAS, most of the tombs are already condemned and may pose danger as it may collapse any time;

WHEREAS, currently there is no space left for interment on the said cemetery;

WHEREAS, the increase in population and eventually the occurrence of death proves the necessity of taking action on this matter;

WHEREAS, to best address the issue the creation of a Technical Working Group, or Task Force that will study, investigate and will give a recommendation regarding this matter is suggested;


 

reconstruction and renovation of the Taytay Public Cemetery and recommending for the creation of a Technical Working Group or Task Force.
