RESOLUTION NO. 209

**REQUESTING THE LOCAL CHIEF EXECUTIVE TO ALLOCATE FUNDS IN THE
AMOUNT OF THREE HUNDRED EIGHTY SIX THOUSAND SIX HUNDRED
SEVENTY PESOS (PHP 386,670.00) FOR THE INSTALLATION OF MERALCO LINE
EXTENSION FACILITIES AT SIMONA SUBDIVISION PHASE II,
BRGY.SAN ISIDRO, TAYTAY, RIZAL**

WHEREAS, pursuant to Section 16 of R.A. 7160, otherwise known as the Local Government Code of 1991, the local government unit is mandated to preserve the convenience of its inhabitants and to exercise other powers essential to the promotion of the general welfare;

WHEREAS, the residents at Simona Subdivision Phase II, Brgy. San Isidro, this municipality, has conveyed to the Municipal Government of Taytay, their concern regarding the need of having MERALCO line extension facilities thereat, wherein as per evaluation by the MERALCO Cainta Business Center, the project would entail an amount to be shouldered by the applicant;


WHEREAS, to address this concern, it is imperative for this Sangguniang Bayan to adopt a corresponding measure, by way of allocating funds needed for this project all in the interest of promoting the general welfare;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the Sangguniang Bayan in session duly assembled, hereby requests the Local Chief Executive to allocate the amount of Three Hundred Eighty Six Thousand Six Hundred Seventy Pesos (Php 386,670.00) for the installation of MERALCO line extension facilities at Simona Subdivision Phase II, Brgy. San Isidro, Taytay, Rizal.
