FUND FOR THE PURCHASE OF TWO (2) PATROL CARS AND
ADDITIONAL FUND FOR OTHER PURPOSES COMING FROM THE
INTELLIGENCE FUND TO BE USED BY THE TAYTAY PNP**

WHEREAS, Section 447 (ii), the Sangguniang Bayan shall maintain peace and order by enacting measures to prevent and suppress lawlessness, disorder, riot, violence, rebellion or sedition and impose penalties for the violation of said ordinances;

WHEREAS, the Police Civilian Relation (PCR) departments aims to educate the public on crime prevention measure, provide data on crime incidents nature of crime offences and wanted criminals, to inform the public on the processes of the criminal justice system, to organized and mobilized the community to have more active role in crime prevention, to initiate programs and activities outside law enforcement to gain the community's support and cooperation in the PNP's Crime Prevention Program and to perform other task as order by Chief of Police;


WHEREAS, the Taytay PNP is also in need of support from the Local Government for an additional patrol cars;
