RESOLUTION NO. 131

**AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE
MAYOR JANET DE LEON- MERCADO TO ENTER INTO AND SIGN A
MEMORANDUM OF AGREEMENT (MOA) WITH MERCURY DRUG
CORPORATION FOR THE AVAILMENT OF A CREDIT LINE FACILITY
RELATIVE TO THE GRANT OF MEDICINES AND MEDICAL SUPPLIES
TO THE NEEDY CONSTITUENTS OF TAYTAY, RIZAL**

WHEREAS, delivery of basic health services including provision of medicines and medical supplies when the need arises, is a paramount concern of this Municipality;

WHEREAS, Mercury Drug Corporation is a credible and dependable drug retailing company that can provide medicines and medical supplies to our needy constituents when the need arises;

WHEREAS, in an effort to strengthen its social services component, the Municipal Government of Taytay has expressed its intention to enter into a partnership with Mercury Drug Corporation for the grant of emergency medicines and medical supplies, to our needy constituents through a credit line facility;

WHEREAS, Mercury Drug Corporation expressed its willingness to provide a credit line facility for the Municipal Government of Taytay, by making emergency medicines and medical supplies available to qualified indigent beneficiaries;

WHEREAS, an amount of Two Hundred Fifty Thousand Pesos (Php 250,000.00) can be appropriated quarterly to fund the grant of emergency medicines and medical supplies from Mercury Drug Corporation through the credit line facility;

WHEREAS, the terms and conditions which the Municipal Government of Taytay and Mercury Drug Corporation will agree upon shall be embodied in the Memorandum of Agreement (as per attached draft);

WHEREAS, Section 444 (b) (1) (vi) of the Local Government Code states that, the Municipal Mayor is vested with the power to represent the Municipality in all its business transactions, in particular, to enter into and sign a memorandum of agreement with Mercury Drug Corporation for the availment of a credit line facility relative to the grant of emergency medicines and medical supplies;


WHEREFORE, BE IT RESOLVED As It Is Hereby Resolved by the 9th Sangguniang Bayan of Taytay, Rizal, In Session Duly Assembled, hereby **AUTHORIZES THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JANET DE LEON-MERCADO TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH MERCURY DRUG CORPORATION FOR THE AVAILMENT OF A CREDIT LINE FACILITY RELATIVE TO THE PROVISION OF MEDICINES AND MEDICAL SUPPLIES TO THE NEEDY CONSTITUENTS OF TAYTAY, RIZAL;**

RESOLVED, that the Memorandum of Agreement shall be ratified first by the Sangguniang Bayan before its full implementation;

RESOLVED FURTHER, that copies of this Resolution be forwarded to all concerned for their information and appropriate action.
