WHEREAS, Sangguniang Bayan has passed Municipal Ordinance No. 33 series of 1999 "Providing Towing and Impounding of Illegally Park and/or Stalled Vehicles within the Jurisdiction of Taytay, Rizal that was amended by Municipal Ordinance No. 6 series of 2003";

WHEREAS, the municipality is mandated to ensure and promote the general welfare of its constituents essential and incidental to its effective and efficient governance;

WHEREAS, to ease the burden on the current traffic flow, there is a need to ensure the Implementation of Ordinance No. 33 series of 1999 and Municipal Ordinance No. 6 series of 2003;

WHEREAS, the Local Government Unit may enter into joint ventures and such cooperative agreements with people's and non-governmental organization to engage in the delivery of certain services;



Janet de Leon-Mercado to enter into a Memorandum of Agreement (MOA) or Contract to any Towing Agency for the implementation of the Towing Ordinance this municipality;

RESOLVED FURTHER, that the Memorandum of Agreement (MOA) shall be ratified first by the Sangguniang Bayan before its full implementation;
