RESOLUTION NO. 188

A RESOLUTION AMENDING RESOLUTION NO. 49 SERIES OF 2010
TO BE READ AS:

AUTHORIZING THE MUNICIPAL MAYOR HON. JANET DE LEON-MERCADO TO NEGOTIATE AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH MR. MIGUEL SANTOS (REPRESENTATIVE OF THE DECEASED HEIRS OF MR. HERMINIO SANTOS), MR. ANUAR PALMERAS AND THE NAGKAKAISANG MAGKAKAPITBAHAY KAY MAITIM, BRGY. STA. ANA FOR PERMANENT RIGHT OF WAY GOING TO HIGHWAY 2000 PHASE II

WHEREAS, on June 10, 2010, Sangguniang Bayan has passed Resolution No. 49 Series of 2010 giving authority to the former Local Chief Executive to negotiate and enter into a Memorandum of Agreement with Mr. Miguel Santos (Representative of the deceased heirs of Mr. Herminio Santos), Mr. Anuar Palmeras and the Nagkakaisang Magkakapitbahay Kay Maitim, Brgy. Sta. Ana for permanent right of way going to Highway 2000 Phase II;

WHEREAS, pursuant to Section 444 of R.A. 7160 also known as Local Government Code 1991 (a) the Municipal Mayor as the Chief Executive of the Municipal Government shall exercise such powers and perform duties and functions as provided by this Code and other laws;

WHEREAS, the temporary right of way of Nagkakaisang Magkakapitbahay Kay Maitim is owned by the sibling of Miguel Santos, Herminio Santos (deceased) and Carmelita Barrantes and the other lot located in front of the Santos' is owned by Mr. Anuar Palmeras;

WHEREAS, the residents of Nagkakaisang Magkakapitbahay Kay Maitim is hopeful to have a proper passage for their daily activities that would benefit them among others;

WHEREAS, the owners of the lots are willing to sell the land in amicable amount as agreed by both parties involved;


WHEREAS, the residents of Nagkakaisang Magkakapitbahay Kay Maitim of Brgy. Sta. Ana seeks the help of the Local Government Unit to facilitate their permanent right of way;

NOW THEREFORE, BE IT RESOLVED, as it is resolved, the 9th Sangguniang Bayan duly assembled in a session, hereby authorizes the Municipal Mayor Hon. Janet De Leon-Mercado to negotiate and enter into a Memorandum of Agreement with Mr. Miguel Santos (Representative of the deceased heirs of Herminio Santos), Mr. Anuar Palmeras and the Nagkakaisang Magkakapitbahay Kay Maitim, Brgy. Sta. Ana for permanent right of way going to Highway 2000 Phase II;
