HONORABLE JANET DE LEON-MERCADO TO ENTER INTO AND SIGN A  
MEMORANDUM OF AGREEMENT(MOA) WITH THE DEPARTMENT OF  
SOCIAL WELFARE AND DEVELOPMENT FOR THE IMPLEMENTATION OF  
THE ENHANCED ASSISTANCE TO INDIVIDUALS IN CRISIS (EAICS) TO

**WHEREAS,** National Government Agencies (NGAs) and other funding agencies, from time to time, tap Local Government Units to Implement their projects or programs to reach as many number of constituents at the grassroots levels as possible;

**WHEREAS,** BOUNDED BY THE PROVISION OF THE Omnibus Guidelines on the Management of DSWD Operated Crisis Intervention Units, the Department of Social Welfare and Development is mandated to implement the Comprehensive and Integrated Delivery of Social Services (CISDD);

**WHEREAS**, a Memorandum of Agreement between the Local Chief Executive and the Department of Social Welfare and Development is need facilitate the implementation of the Comprehensive and Integrated Delivery of Social Services (CIDSS) that will benefit the indigent families of the Municipality of Taytay;


**WHEREAS**, that the said MOA shall be ratified first by the Sangguniang Bayan before its full implementation;
