**A SANGGUNIANG BAYAN RESOLUTION SUPPORTING THE
RESOLUTION OF THE SANGGUNIANG BARANGAY OF
MUZON REQUESTING J.S. CRUZ CONSTRUCTION AND
DEVELOPMENT INCORPORATED (CRUZCON) TO EXTEND
THE TIME FRAME OF THEIR DEED OF DONATION
PERTAINING TO THE 6,322 SQ. METERS UNREGISTERED
PARCEL OF LAND SITUATED IN HULONG BANGIAD
BARANGAY MUZON IN THIS MUNICIPALITY**

WHEREAS, last May 6, 2010, the Sangguniang Barangay of Muzon passed Resolution No. AC-033-14 "A Resolution requesting J.S. Cruz Construction and Development Incorporated (CRUZCON) to extend their deed of donation time frame duration in favor of Barangay Muzon pertaining to the 6,322 square meters unregistered parcel of land situated at Hulong Bangiad Barangay Muzon;

WHEREAS, Barangay Muzon had long been wishing and realizing its dire need of such a sizeable land, purposively to cope with the increasing school enrollees yearly, and for other multi-purpose structures to be established, in preparation to the increasing population in this particular community;


WHEREAS, the subject Terms and Conditions primarily emphasized and stipulated in the Deed of Donation that the Donee, within the given time frame duration of four (4) years from granting thereof, shall meet the specified conditions initially the construction of High School Building and other structures on site for Public use and secondly to set aside an area to be allotted for the original informal settlers on site;

NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Bayan of Taytay, Rizal duly assembled in session to hereby pass a resolution of the Sangguniang Barangay of Muzon requesting J.S. Cruz Construction and Development Incorporated (CRUZCON) to extend their deed of donation time frame duration in favor of Barangay Muzon pertaining to the 6,322 sq. meters unregistered parcel of land situated in Hulong Bangiad, Barangay Muzon Taytay, Rizal;


RESOLVED FURTHER, that copies of this resolution be submitted to the higher authorities and duly constituted bodies for appropriate action pursuant to the existing laws;
