## **RESOLUTION NO 295**

JANET DE LEON-MERCADO TO NEGOTIATE AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE LANDBANK OF THE PHILIPPINES THAT WILL PROVIDE AN EFFICIENT ELECTRONIC PAYROLL SYSTEM THROUGH AUTOMATED TELLER MACHINES (ATM) FOR THE LOCAL GOVERNMENT EMPLOYEES OF TAYTAY**

WHEREAS, our Municipality is still using the traditional way of payroll system, nevertheless, implementation of an Electronic Payroll System through Automated Teller Machine (ATM's) will provide a beneficial and convenient payroll system for the employees of our Municipality in saving resources, time and energy in the preparation and release of salary;

WHEREAS, the Sangguniang Bayan requests the Landbank of the Philippines to present its services offered pertaining to the Electronic Payroll System before its full implementation;


WHEREAS, the Sangguniang Bayan shall ratify the Memorandum of Agreement before its full implementation;
