**RESOLUTION RECOMMENDING TO HON. CARLITO G. GONZAGA, MUNICIPAL VICE-MAYOR/HEAD LEGISLATIVE BRANCH OF THE LOCAL GOVERNMENT UNIT OF TAYTAY, RIZAL TO CONSIDER RE-ALIGNMENT OF FUNDS IN THE AMOUNT OF TWENTY THREE THOUSAND FOUR HUNDRED EIGHT FOUR PESOS AND FIFTY ONE CENTAVOS (PHP 23,484.51) REPRESENTING TERMINAL PAY BENEFITS OF MR. EDWARD B. PILI WHO JOINED OUR CREATOR OCTOBER 29, 2014**

WHEREAS, Mr. Edward B. Pili, an employee at the Legislative Department, joined our creator October 29, 2014 and is entitled to terminal pay benefits as submitted by the Human Resource and Management Office;

WHEREAS, Mr. Edward B. Pili, having rendered actual services, is entitled to terminal pay benefits in the amount of Twenty Three Thousand Four Hundred Eighty Four Pesos and Fifty One Centavos (PHP 23,484.51);

WHEREAS, due to the untimely demise of Mr. Edward B. Pili, his entitlement for terminal pay was not considered in the Annual Budget FY 2015;

WHEREFORE, BE IT RESOLVED, as it is hereby resolved by the 9<sup>th</sup> Sangguniang Bayan, Taytay, Rizal in session duly assembled, hereby RECOMMENDS TO HON. CARLITO G. 

RESOLVED FINALLY, that copy of this Resolution be forwarded to all concerned for their information and appropriate action.


