WHEREAS, the Bureau of Immigration is requesting for an available space in our LGU for them to set up a relocation of their field office for their services.



RESOLVED FURTHER, that the Memorandum of Agreement be subject to the ratification of the Sangguniang Bayan before its full implementation


RESOLVED FURTHERMORE, that the copy of this Resolution be furnished to all concerned for their information and appropriate action.
