RESOLUTION NO. 322

**A RESOLUTION GRANTING THE FY 2015 PRODUCTIVITY ENHANCEMENT
INCENTIVE (PEI) TO ALL QUALIFIED LOCAL GOVERNMENT EMPLOYEES
BASED ON THE PROVISIONS OF EXECUTIVE ORDER NO. 181 ISSUED BY THE
OFFICE OF THE PRESIDENT ON MAY 15, 2015**

WHEREAS, the Office of the President issued Executive Order No. 181 granting the FY 2015 Productivity Enhancement Incentive (PEI) to all National and Local Government Employees at an equivalent amount of One Month Basic Salary or PHP 5,000.00 based on the conditions stipulated on the said Executive Order;

WHEREAS, under Section 4d of the said Executive Order, the Municipality of Taytay qualifies to the requirement in giving the PEI at the rate of one month basic salary, the requirement of being compliant with the requirements under the Good Financial Housekeeping as component of the FY 2014 Seal of Good Local Governance of the DILG;

WHEREAS, the Honorable Mayor Janet De Leon – Mercado, in coordination with the Municipal Budget Officer, the Municipal Treasurer and the HRMO Head, has established the needed amount in the grant of the subject PEI to be sourced from the PS savings of several vacant positions from January to May of the Current Year;


WHEREAS, funding of the subject PEI shall be done thru an augmentation of fund by the Honorable Mayor and the Honorable Vice Mayor of their respective appropriations as per the authority given to them by this Honorable Sanggunian under Section 9 of Ordinance No. 17 or the FY 2015 Annual Budget of the Municipality of Taytay;

WHEREFORE, BE IT RESOLVED, as it is hereby resolved by the 9th Sangguniang Bayan of Taytay Rizal in Session duly assembled, hereby authorizes the grant of the one time Productivity Enhancement Incentive (PEI) at a rate of One Month Basic Salary based on the provisions of Executive Order No. 181 issued by the Office of the President on May 15, 2015;


