**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE/MUNICIPAL MAYOR, HONORABLE JANET DE LEON-MERCADO IN BEHALF OF THE MUNICIPALITY OF TAYTAY TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF TRADE AND INDUSTRY REGION IV-A (DTI), REPRESENTED BY ITS REGIONAL DIRECTOR, MS. MARILOU QUINCO-TOLEDO AND WITH THE PHILIPPINE CHAMBER OF COMMERCE & INDUSTRY-TAYTAY CHAPTER (PCCI) REPRESENTED BY ITS PRESIDENT, MR. JUAN MARTIN G. BARREDO**

WHEREAS, Republic Act No. 10644 An Act promoting job generation and inclusive Growth through the Development of Micro, Small and Medium Enterprises known as the "Go Negosyo Act";

WHEREAS, the "Go Negosyo Act" mandates the creation of Negosyo Centers which would be directly supervised by the DTI in every province, city and municipality;

WHEREAS, the Negosyo Centers would facilitate development programs and provide support for all aspects of maintaining business;

WHEREAS, the Local Government Unit of Taytay was considered by DTI as the Pilot Negosyo Center in the Province of Rizal;

WHEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the 9<sup>th</sup> Sangguniang Bayan of Taytay, Rizal in Session duly assembled, hereby Authorize the Local Chief Executive Municipal Mayor Janet De Leon-Mercado in behalf of the Municipality of Taytay to enter into a Memorandum of Agreement with the Department of Trade and Industry (DTI) Region IV-A represented by its Regional Director, Ms. Marilou Quinco-Toledo and with Philippine Chamber of Commerce and Industry Taytay Chapter (PCCI) represented by its President, Mr. Juan Martin G. Barredo;


RESOLVED FURTHER, that the Memorandum of Agreement be ratified by the Sangguniang Bayan before its full implementation.
