**REQUESTING THE DEPARTMENT OF HEALTH (DOH) REGIONAL
OFFICE – IVA (CALABARZON) TO TRANSFER THE OTHER
REMAINING FUND FOR THE YEAR 2015 HEALTH FACILITIES
ENHANCEMENT PROGRAM FUND FOR THE RHU TO CONSTRUCT
NEW RHU FACILITIES IN THIS MUNICIPALITY OF TAYTAY, RIZAL**

WHEREAS, The General Welfare Clause of R.A. 7160, otherwise known as the Local Government Code of 1991, provides:

SECTION 16. General Welfare- "every local government unit shall exercise the powers expressly granted those necessarily implied there from, appropriate or incidental for its efficient and effective governance, and those which are essential to the general welfare",

WHEREAS, this Municipality through the support and help of DOH have been recently granted eight (8) new RHU facilities located in five (5) different barangay and presently serving our constituents;

WHEREAS, it is but proper to transfer and allocate the said health facilities enhancement program to construct additional RHU facilities in:

1. From Taytay CHO TO L. WOOD ST., BRGY. DOLORES
2. From Muzon RHU TO HOME AT LAST SUBDIVISION, BRGY. MUZON
3. From Taytay RHU VA TO EXODUS, BRGY. STA. ANA


WHEREAS, through this, the more RHU facilities, the more health care can be serve as "SERBISYONG NARARAMDAMAN" to protect and promote the right of the people and instill health consciousness among them as per Philippine Constitution under Section 15;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved a Resolution requesting the Department of Health (DOH) Regional Office-IVA (CALABARZON) to transfer the other remaining fund for the year 2015 health facilities enhancement program fund for the RHU to construct new RHU facilities on this Municipality of Taytay, Rizal;
