**RESOLUTION NO. 350**

**REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) - RIZAL FOR THE CONCRETING OF THE RIVER BANK ALONG PATOTO CREEK AT J. DE LEON STREET, BARANGAY MUZON, TAYTAY, RIZAL AS AN ALTERNATIVE ROUTE TO THE COASTAL ROAD BARANGAY MUZON, THIS MUNICIPALITY**

WHEREAS, the Sangguniang Barangay of Brgy. Muzon, Taytay, Rizal adopted Resolution No. AC-062-15 series of 2015 "Resolution requesting to the Office of the Hon. Janet De Leon-Mercado of Taytay, Rizal to appropriate funds for the development and concreting of the river bank along Patoto Creek at J. De Leon Street as an alternative route going through the coastal road in Brgy. Muzon, Taytay, Rizal;

WHEREAS, Juan De Leon Street (formerly Sumulong St.) in Brgy. Muzon serves as the only access route to the national road utilized by the residents and commuters resulting to difficulty, inconvenience and delays not only on the social movement of the general public but also on the economic activity in the area;

WHEREAS, the proposed development and concreting of the river bank along Patoto Creek, J. De Leon Street, Barangay Muzon would ease the flow of traffic in the area as it would also serve as an alternative route going through the coastal road thus increasing the economic activity which will benefit the general public;

WHEREAS, the Sangguniang Bayan finds the development and concreting of the River Bank along Patoto Creek at J. De Leon Street, Barangay Muzon consistent with the thrusts and priorities of the Municipal Development Plan;




RESOLVED FURTHER, that the copy of this Resolution be forwarded to all concerned for their information and appropriate action;
