## **RESOLUTION NO. 365**

**RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) THROUGH DISTRICT ENGINEER ROGELIO M. CRESPO – 1<sup>ST</sup> DISTRICT, PROVINCE OF RIZAL TO FAST TRACK THE IMPLEMENTATION OF TWO (2) MAJOR ROAD NETWORKS:**

- 1) REPAIR/REHABILITATION/IMPROVEMENT (ADDITIONAL PAVEMENT WIDTH WITH DRAINAGE IMPROVEMENT) OF MANILA EAST ROAD; AND**
- 2) REHABILITATION/RECONSTRUCTION/UPGRADING OF DAMAGED PAVED NATIONAL ROAD INCLUDING DRAINAGE OF MANILA EAST ROAD HIGHWAY 2000, THIS MUNICIPALITY**

WHEREAS, the Municipal Government of Taytay, Province of Rizal recognizes the substantial support of the Department of Public Works and Highways (DPWH) in undertaking and implementing various infrastructure projects within the Municipality of Taytay;

WHEREAS, foremost of these infrastructure projects are road networks that increases road capacity, eliminates traffic congestion, mitigates flood and increases the economic activity and social movement of the general public;

WHEREAS, two(2) major road networks are being undertaken, constructed and implemented at the same time by the Department of Public Works and Highways-1<sup>st</sup> District of Rizal within the Municipality;1) Repair/Rehabilitation/Improvement (Additional Pavement width with Drainage Improvement) of Manila East Road(from Barangay San Juan to Barangay Muzon) and 2) Rehabilitation/Reconstruction/Upgrading of Damaged Paved National Road including Drainage of Manila East Road Highway 2000;

WHEREAS, the simultaneous undertaking/construction and implementation of these two (2) major road networks have caused severe traffic congestion, and have taken its toll on commuters and motorists, as well as the economic activity and social movement of the general public;

WHEREAS, with the advent of the Christmas Season, there is a need to fast track the undertaking construction and implementation of these two (2) major road networks so that the very purpose of its conception may be realized;


WHEREFORE, BE IT RESOLVED, As it is Hereby Resolved by the 9<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in Session duly assembled, hereby **ADOPTS A RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) THROUGH DISTRICT ENGINEER ROGELIO M. CRESPO -1<sup>ST</sup> DISTRICT, PROVINCE OF RIZAL TO FAST TRACK THE IMPLEMENTATION OF TWO (2) MAJOR ROAD NETWORKS;1) REPAIR/REHABILITATION/IMPROVEMENT(ADDITIONAL PAVEMENT WIDTH WITH DRAINAGE IMPROVEMENT) OF MANILA EAST ROAD; AND 2) REHABILITATION/RECONSTRUCTION/UPGRADING OF DAMAGES PAVED NATIONAL ROAD INCLUDING DRAINAGE OF MANILA EAST ROAD HIGHWAYS 2000, THIS MUNICIPALITY.**
