COUNCIL (MDC) RESOLUTION NO. 2016-003 "RESOLUTION
APPROPRIATING THE AMOUNT OF NINETY THREE MILLION THREE
HUNDRED EIGHTY THREE THOUSAND NINETY THREE PESOS AND
EIGHTY CENTAVOS (PHP 93,383,093.80) REPRESENTING THE 20%
DEVELOPMENT FUND FY 2017 TO VARIOUS PRIORITY
PROJECTS/PROGRAMS FOR THE MUNICIPALITY**

WHEREAS, section 287 of the Local Government Code, states that every LGU shall appropriate in its annual budget no less than twenty percent (20%) of its Annual Internal Revenue Allotment for development projects;

WHEREAS, submitted to the Honorable August Body is the Municipal Development Council (MDC) Resolution No. 2016-003 appropriating the amount of Ninety Three Million Three Hundred Eighty Three Thousand Ninety Three Pesos and Eighty Centavos (Php 93,383,093.80), the amount equivalent to the 20% of Annual Internal Revenue Allotment of this Municipality, for ratification;

WHEREAS, integrated in MDC Resolution No. 2016-003 are priority development projects to be funded out of the 20% Development Fund for FY 2017;




RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action;
