RESOLUTION NO. 384

REQUESTING HIS EXCELLENCY BENIGNO SIMEON C. AQUINO III, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES THRU HONORABLE FLORENCIO B. ABAD, SECRETARY OF THE DEPARTMENT OF BUDGET AND MANAGEMENT FOR ALLOCATION OF FUNDS FOR THE CONSTRUCTION OF BAHAY PAG-ASA, TAYTAY, RIZAL

WHEREAS, pursuant to the provisions of the law, the Municipal Government of Taytay, Rizal, shall protect the best interests of the child and likewise recognizes the right of children to assistance, including proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty and exploitation, and other conditions prejudicial to their development.

WHEREAS, Section 50 of R.A. 9344 calls for the immediate establishment of local detention homes for children in conflict with the law; further amended by R.A. 10630, which states that Local Government Units should include construction and maintenance of Bahay Pag-asa;

WHEREAS, Section 2 of R.A. 10630 states:

"(s) 'Bahay Pag-asa' – refers to a 24-hour child-caring institution established, funded and managed by local government units (LGUs) and licensed and/or accredited non-government organizations (NGOs) providing short-term residential care for children in conflict with the law who are above fifteen (15) but below eighteen (18) years of age who are awaiting court disposition of their cases or transfer to other agencies or jurisdiction.

"Part of the features of a 'Bahay Pag-asa' is an intensive juvenile intervention and support center. This will cater to children in conflict with the law in accordance with Sections 20, 20-A and 20-B hereof.

WHEREAS, the construction of Bahay Pag-asa would require a huge amount to which the Municipal Government of Taytay cannot financially support or provide, thus would require funding;

WHEREFORE, BE IT RESOLVED, As It Is Hereby Resolved by the 9th Sangguniang Bayan of Taytay, Rizal, In Session Duly Assembled, hereby, EARNESTLY REQUESTS HIS EXCELLENCY BENIGNO SIMEON C. AQUINO III, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES THRU HONORABLE FLORENCIO B. ABAD, SECRETARY OF THE DEPARTMENT OF BUDGET AND MANAGEMENT FOR ALLOCATION OF FUNDS FOR THE CONSTRUCTION OF BAHAY PAG-ASA, TAYTAY, RIZAL


