JANET DE LEON-MERCADO, MUNICIPAL MAYOR TO NEGOTIATE, SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT IN BEHALF OF THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL WITH THE BUKLOD MAGKAKABALIKAT ASSOCIATION INCORPORATED OF SAN FRANCISCO VILLAGE, BARANGAY MUZON, TAYTAY, RIZAL

WHEREAS, Buklod Magkakabalikat Association Incorporated proposes to purchase the lot where their sixty six members (66) members resides for almost more than a decade;

WHEREAS, the association had verbalized their intention to the Local Chief Executive Hon. Janet De Leon Mercado who then referred the matter to the Sangguniang Bayan for appropriate legislative action;


RESOLVED FURTHERMORE, that the copy of Resolution be forwarded to all concerned for their information and appropriate action;
