WHEREAS, the donors, Simona Homeowners Association is the registered owners of a parcel of land classified as open space and covered by Transfer Certificate Title (TCT) No. 692262 located at Sitio Simona, Brgy. San Isidro, Taytay, Rizal;

WHEREAS, the Simona Homeowners Association had already donated to this Municipality the open space of Simona Subdivision with an area of one thousand six hundred ninety six (1,696) square meters last 2008;

WHEREAS, the donation of Open Space of Simona Subdivision to the Local Government will give way for the construction of Simona High School;


