RESOLUTION NO. 137 s. 2017

AUTHORIZING THE MUN. MAYOR HON. GEORGE RICARDO R. GACULA II TO ENTER INTO A USUFRUCT AGREEMENT WITH HON. REBECCA A. YNARES, GOVERNOR- PROVINCE OF RIZAL FOR THE USE AND MAINTENANCE OF A PORTION OF LOT/SPACE FOR THE CONSTRUCTION OF REFORMATION COMPLEX INTENDED FOR DRUG AFFLICTED RESIDENTS OF THE MUNICIPALITY LOCATED AT THE YES CITY IN BRGY. CUYAMBAY, TANAY, RIZAL

WHEREAS, in the Local Government Code Section 17(f) Chapter 2 General Powers states and provides that a "next higher level of local government unit may provide or augment the basic services and facilities assigned to a lower level of local government unit when such services or facilities are not made available or, if made available are inadequate to meet the requirements of its inhabitants";

WHEREAS, the Provincial Government of Rizal will allocate fourteen (14) hectares lot in Yes City at Barangay Cuyambay, Tanay Rizal for drug afflicted residents of the fourteen (14) towns of the province meant for Rehabilitation and Reformation Complex Facility;

WHEREAS, the Local Chief Executive Hon. George Ricardo R. Gacula II had requested for a portion of the stated lot space more or less one (1) hectare, meant for the affected residents of Taytay by which the construction, maintenance and operation of the stated purpose will be shouldered by municipal fund;

WHEREAS, a request from the Local Chief Executive Hon. George Ricardo R. Gacula II for an authorization to enter into Usufruct agreement is hereby convey to the 10th Sangguniang Bayan;


NOW THEREFORE RESOLVED, as it is hereby resolved by the 10th Sanggunian Bayan in session hereby authorizes the Municipal Mayor Hon. George Ricardo R. Gacula II to enter into a Usufruct Agreement with Hon. Rebecca A. Ynares, Governor-Province of Rizal for the use and maintenance of a portion of lot/space for the construction of Reformation Complex intended for drug afflicted residents of the municipality located at the Yes City in Barangay Cuyambay, Taytay, Rizal.

RESOLVED FURTHER, that the Usufruct Agreement shall be ratified by the Sangguniang Bayan before its full implementation.
