A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR HON. GEORGE RICARDO R.GACULA II TO NEGOTIATE AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH ANY PERSON OR ENTITY WILLING TO SELL THEIR PROPERTY TO BE USED FOR THE EXPANSION AND CONSTRUCTION OF SCHOOL BUILDINGS FOR MANUEL I. SANTOS MEMORIAL NATIONAL HIGH-SCHOOL IN BARANGAY SAN JUAN, TAYTAY, RIZAL

WHEREAS, in the implementation of the on-going K to 12 Basic Education Program of the Department of Education, additional school buildings had to be constructed to meet the demands of the growing population of students enrolling to comply and finish the program;

WHEREAS, the School Officials together with the Parents and Teachers Association of Manuel I. Santos Memorial National High-School had requested the Local Officials of Taytay to provide their students additional school facility intended for the program;

WHEREAS, in order to address the concerns of the education sector of the locality, the Sangguniang Bayan of Taytay had deliberated and deemed necessary to authorize the Local Chief Executive to negotiate or enter into a Memorandum of Agreement with any person or entity willing to sell their property;



Santos Memorial National High- School in Barangay San Juan, Taytay, Rizal;

RESOLVED FURTHER, that the Memorandum of Agreement shall be ratified by the Sangguniang Bayan before its full implementation;


RESOLVED FURTHERMORE, that the copy of the resolution be furnished to all concern for their information and appropriate action.
