A RESOLUTION REITERATING THE DECLARATION THAT LUPANG ARENDA IN BARANGAY STA. ANA IS HABITABLE AND SUITABLE FOR A SOCIALIZED HOUSING PROGRAM/PROJECT BASED ON THE FINDINGS AND RECOMMENDATIONS OF THE LOCAL TECHNICAL WORKING GROUP FOR LUPANG ARENDA (LTWG) OF THIS MUNICIPALITY

WHEREAS, the security of tenure of the residents of Lupang Arenda is continuously being under uncertainly due to the issuance of Executive Order No. 854 by President Gloria Macapagal Arroyo which revoked Presidential Proclamation No. 704 by President Ramos declaring Lupang Arenda as a socialized housing project;

WHEREAS, the Sangguniang Bayan have passed, Resolution No. 186 series of 2017 requesting President Rodrigo Roa Duterte, President of the Philippines to issue a new Presidential Proclamation proclaiming the presently occupied community area of Lupang Aranda as socialized housing project and to declare the remaining unoccupied area as protected area;

WHEREAS, on September 6, 2013 the Local Chief Executive issued EO No. 22, creating the Local Technical Working Group Lupang Arenda which concluded that Lupang Arenda is habitable and viable as a housing project and has recommended the petition for the issuance a Presidential Proclamation declaring Lupang Arenda as housing project for the actual occupants as beneficiaries;




