A RESOLUTION REQUESTING THE HONORABLE CONGRESSMAN MICHAEL JOHN R. DUAVIT, REPRESENTATIVE, 1ST DISTRICT OF RIZAL TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF A CONCRETE OVERLAY AT PHASE 3 SAN LORENZO RUIZ, BARANGAY SAN JUAN, TAYTAY, RIZAL

WHEREAS, several roads located at Phase 3 of San Lorenzo Ruiz, Barangay San Juan, Taytay, Rizal have been heavily damaged due to flooding and stagnation of floodwater during rainy seasons, making everyday life difficult for the families residing at the area;

WHEREAS, damaged roads cause traffic and road safety hazards which in turn affect not only our constituents, but also cause delays to the local economy and disruption of businesses of the surrounding areas;

WHEREAS, the construction of concrete overlay at Phase 3 of San Lorenzo Ruiz will greatly improve road safety, prevent accidents, as well as diminish delays to economic and business movement in the Municipality;

WHEREAS, the Municipal Government of Taytay cannot financially support the said project because of insufficient funds;




RESOLVED FURTHER, that a copy of this Resolution be forwarded to the Office of Congressman Duavit for their information and consideration;
