A RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) DISTRICT I RIZAL PROVINCE THRU ENGINEER ROGELIO S. CRESPO TO APPROVE THE INSTALLATION OF A PEDESTRIAN LANE IN FRONT OF BAHAY-KAWAYAN RESTAURANT AT THE MANILA EAST ROAD, BARANGAY SAN JUAN, TAYTAY, RIZAL

WHEREAS, section 16 of R.A. 7160 also known as the Local Government Code of 1991 states that:

WHEREAS, the said area is an accident-prone area for motorists as well as for pedestrians crossing the street resulting to a series of fatal accidents;


WHEREAS, it will be a big help to put up a pedestrian lane to prevent more accidents in the future;


RESOLVED FURTHER, that copy of this Resolution be forwarded to all concerned for their information and appropriate action;
