RESOLUTION NO. 240 s. 2017

APPROVING AND RATIFYING THE TAYTAY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (TDRRMC) A RESOLUTION NO. 2017-01 "A RESOLUTION REVISING THE FY 2017 TAYTAY DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN (TDRRMFIP) TO INCLUDE ADDITIONAL PROGRAMS AND PROJECTS IN THE TOTAL AMOUNT OF THIRTY FIVE MILLION FIVE HUNDRED THOUSAND (P35,500,000.00) PESOS FOR THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL AND THE UTILIZATION OF SPECIAL TRUST FUND FOR THE PURPOSE"

WHEREAS, Republic Act (RA) No. 10121 also known as Philippine Disaster Risk Reduction and Management Act of 2010 granted Local Government Units (LGUs) greater flexibility towards disaster mitigation, preparation and recovery;

WHEREAS, section 12 (a) of R. A. 10121 states that Local Disaster Risk Reduction and Management Office (LDRRMO) shall be responsible for setting the direction, development, implementation and coordination of disaster risk management programs within their territorial jurisdiction; Section 12 (c)(6) the LDRRMO shall formulate and implement a comprehensive and integrated LDRRMP in accordance with the national, regional and provincial framework and policies on disaster risk reduction in close coordination with the Local Development Councils (LDCs); Section 12 (c)(7) prepare and submit to the Local Sangguniang through the LDRRMC and the LDC the Annual LDRRMO Plan and Budget, the proposed programming of the LDRRMF, other dedicated disaster risk reduction and management resources, and other regular funding source/s and budgetary support of the LDRRMO;

WHEREAS, both our Treasury and Accounting Departments have assured the TDRRMC of the availability of funds in the Special Trust Fund to cover the budget for the additional programs and projects to be included in the FY 2017 TDRRMFIP;


WHEREAS, The TAYTAY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL'S (TDRRMC) Resolution is in accordance with the provisions of the Local Government Code of 1991 or R. A. 7160 and R. A. 10121;


RESOLVED FURTHER, that copy of this Resolution be forwarded to all concerned for their information and appropriate action;
