A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II TO NEGOTIATE WITH HOMEOWNERS OF PRIVATE SUBDIVISION ON THE POSSIBLE PASSAGE OF VEHICLES ON THEIR SUBDIVISION AS ALTERNATE ROUTE ESPECIALLY DURING SPECIAL OCCASION LIKE CHRISTMAS HOLIDAY

WHEREAS, heavy traffic in Ortigas Avenue Extension and High-way 2000 is extensive and serious that causes delay to the everyday transaction of each constituents not only in our Municipality but also to different areas in Rizal and Metro Manila;

WHEREAS, the local government unit has the power to make an alternative solution to ease the congested traffic in our area and to have an efficient and effective governance that will promote the general welfare of the people;

WHEREAS, there are some private areas in our Municipality that can be an alternative route and be possible to use as a passage way for private vehicles that are near and connected to the areas with an existing traffic congestion;




RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action.
