WHEREAS, the said Deed of Donation will give an opportunity to the community to be improved and developed;


WHEREAS, the duly signed Deed of Donation shall be ratified by the Sangguniang Bayan before its full implementation;


RESOLVED FURTHER, that the copy of this resolution be furnished to all concerned for their information and appropriate action.
