**A RESOLUTION DECLARING FULL AND UNWAVERING SUPPORT TO THE PRE-PROCLAMATION COMMITTEE FOR LUPANG ARENDA RESOLUTION NO. 2 S. 2018 ENTITLED “RESOLUTION CONCLUDING THE ACTIVITIES FOR THE COMPLETE STAFF WORK OF THE PRE-PROCLAMATION COMMITTEE AND ENDORSING TO HIS EXCELLENCY PRESIDENT RODRIGO ROA DUTERTE FOR THE ISSUANCE OF A PRESIDENTIAL PROCLAMATION DECLARING CERTAIN PORTIONS OF PUBLIC LAND RS-000427 OPEN FOR DISPOSITION TO QUALIFIED OCCUPANTS FOR SOCIALIZED HOUSING**

WHEREAS, the struggle for Security of Tenure in Lupang Arenda, has been a burning issue for the thousand families occupying the public land;

WHEREAS, the Local Government of Taytay and Alliance of People's Organization in Lupang Arenda (APOLA) worked hand in hand to address the issue;

WHEREAS, in support of this cause, the Sangguniang Bayan passed Resolution No. 186 s. 2017, among others, entitled "Respectfully requesting President Rodrigo Roa Duterte, President of the Republic of the Philippines, for the issuance of a new Presidential Proclamation proclaiming the presently occupied community area of Lupang Arenda as a socialized housing project and to declare the remaining unoccupied area as protected area, thus appropriating funds thereof;

WHEREAS, on December 2017, the Housing and Urban Development Council Coordinating Council (HUDCC) created a Pre-Proclamation Committee for Lupang Arenda towards realizing the declaration of Lupang Arenda as socialized housing and open to disposition to all qualified actual occupants;

WHEREAS, after four (4) months, the Pre-Proclamation Committee for Lupang Arenda was able to conduct and finish all the necessary meetings and coordination activities resulting the formulation of a Complete Staff Work;

WHEREAS, the Pre-Proclamation Committee passed Resolution No. 2 S. 2018 entitled "Resolution concluding the activities for the complete staff work of the Pre-Proclamation Committee and endorsing to His Excellency, President Rodrigo Roa Duterte for the issuance of a Presidential Proclamation declaring certain portions of public land RS-000427 open for disposition to qualified occupants for socialized housing";

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 10<sup>th</sup> Sangguniang Bayan of Taytay, Rizal duly assembled in session, hereby declares full and unwavering support to the HUDCC Pre-Proclamation Committee for Lupang Arenda Resolution No. 2 s. 2018 entitled "Resolution concluding the activities for the Complete Staff Work of the Pre-Proclamation Committee and endorsing to His Excellency, President Rodrigo Roa Duterte for the issuance of a Presidential Proclamation declaring certain portions of public land RS-000427 open for disposition to qualified occupants for socialized housing;






