WHEREAS, the SAMAHANG BAGONG BUHAY FOUNDATION, INC., who were currently the owner of the road lots and open spaces at Jansenville Subdivision have expressed their intent to donate the titled properties to the Municipal Government of Taytay;


WHEREAS, the duly signed and notarized Deed of Donation shall be ratified by the Sangguniang Bayan before its full implementation;


