

Janet De Leon Mercado to Negotiate and Enter into a Memorandum of Agreement (MOA) With Any Entity for the Acquisition of Property or Lot Suitable for Senior High School (Stand Alone) Project;

WHEREAS, the subject property in the said Memorandum of Agreement has a total land area of 3,899 sq. m. covered by Tax Declaration No. 18-TY-002-09000 which was located at Int. Adhika St., Barangay Dolores, Taytay, Rizal;

WHEREAS, the Heirs of the Galvezes executed a Declaration of Consent and Non-objection Document, dated December 12, 2017, for the development or construction in the said parcel of land that is subject to be purchased by the Municipality that needed to its purpose;

WHEREAS, the purpose of the said Memorandum of Agreement was to purchase the property owned by the Galvez Family and use the said parcel of land as stated for the Expansion and Construction of a School Buildings;




RESOLVED FURTHER, that the copy of this resolution be furnished to all concerned for their information and guidance.
