### RESOLUTION NO. 324 series of 2018

**RESOLUTION REQUESTING HONORABLE REBECCA "NINI" A. YNARES, PROVINCIAL GOVERNOR, PROVINCE OF RIZAL AND HONORABLE MICHAEL JOHN "JACK" DUAVIT, REPRESENTATIVE, 1<sup>ST</sup> DISTRICT OF RIZAL PROVINCE, FOR THE CONSTRUCTION OF TWO (2) PEDESTRIAN OVERPASSES ALONG NATIONAL ROAD, SPECIFICALLY AT GOLDEN CITY SUBDIVISION ALONG MANILA EAST ROAD, BRGY. DOLORES AND AT MUZON ELEMENTARY SCHOOL ALONG NATIONAL ROAD, BRGY. MUZON, THIS MUNICIPALITY**

WHEREAS, Section 16 and Section 17 of Republic Act 7160 otherwise known as the Local Government Code of 1991 expressly mandates Local Government Units to promote the general welfare of its inhabitants which includes the provision of facilities that would give comfort, enhance public health, safety and convenience to all the inhabitants of the Municipality, including the construction of pedestrian overpasses;

WHEREAS, Manila East Road of Barangay Dolores and National Road of Barangay Muzon, both in the Municipality of Taytay, Rizal are major thoroughfares with increased foot traffic and causes difficulty, consumes valuable time, effort and poses danger for pedestrians crossing from and to the stated areas as they will have to wait and brave the hazard of crossing amidst speeding cars, vans, buses, trucks and other kinds of vehicles;

WHEREAS, to help maintain the safety and well-being of the pedestrians and provide convenience to the public when crossing to and from the stated areas, a concrete way of easing the problem is the construction of pedestrian overpasses, specifically at Golden City Subdivision along Manila East Road, Brgy. Dolores and at Muzon Elementary School, Brgy. Muzon, both at the Municipality of Taytay;


WHEREAS, construction of pedestrian overpass would incur a huge amount which the Municipal Government of Taytay cannot financially support;
