WHEREAS, Taytay, Rizal is the catch basin of flood water coming from nearby towns resulting to several flooding that affect the lives of its inhabitants;


WHEREAS, the said funding will be a great help in the flood control program in our Municipality especially in the continuous dredging of its creeks and other waterways;


RESOLVED FURTHER, that the copies of this resolution be furnished to all concerned for their information and appropriate action.
