A RESOLUTION ADOPTING THE "TAYTAY COMPREHENSIVE LOCAL JUVENILE INTERVENTION PROGRAM (CLJIP) FOR CY 2019 – 2021"

WHEREAS, Section 16 of RA 7160, otherwise known as the Local Government Code of 1991 provides that "Every Local government units shall exercise the powers expressly granted, those necessary implied there from, as well as the powers necessary, appropriate or incidental for its effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Section 4 line m of RA 9344, the establishment of a Comprehensive Juvenile Justice and Welfare System – a system dealing with children at risk and children in conflict with the law, which provides child appropriate proceedings, including programs, diversion, rehabilitation, reintegration and aftercare to ensure their normal grown and development;

WHEREAS, Department of Interior and Local Government (DILG) Memorandum Circular 2016-68 provides for the Guidelines for the Local Government Units and the Development of the Comprehensive Local Juvenile Intervention Program (CLJIP);

WHEREAS, the Municipality of Taytay aims to provide the full implementation of intervention/ diversion program/services intended for the Children in Conflict with Law (CICL) and Children at Risk (CAR) with cases in order to lessen the total number of CICL/CAR in this Municipality;




RESOLVED FURTHERMORE, that copies of this resolution be forwarded to all concern for their information and appropriate action.
