RESOLUTION NO. 84 series of 2019

A RESOLUTION DESIGNATING AS THE PROPERTY SITE FOR THE CONSTRUCTION OF THE RIZAL PROVINCIAL HOSPITAL SYSTEM (RPHS) – TAYTAY ANNEX THE PARCELS OF LAND COVERED BY TAX DECLARATION NOS. 18-TY-002-08242 AND 18-TY-001-12950

WHEREAS, the Sangguniang Bayan ng Taytay, Rizal adopted Resolution No. 15, series of 2019 on August 20, 2019; requesting the Hon. Gov. Rebecca A. Ynares to construct and manage a Provincial General Hospital within the jurisdiction of the Municipal Government of Taytay in furtherance of its duty to effectively provide the basic services and facilities needed by the constituents;

WHEREAS, in response with the request and finding the same as consistent with the thrust of the Rizal Provincial Government to ensure the delivery of basic health services to the Rizaleños, the 29th Sangguniang Panlalawigan ng Rizal issued Resolution No. 421, s. 2019 on September 02, 2019, approving the establishment of Rizal Provincial Hospital System (RPHS) – Taytay Annex;

WHEREAS, to bring this into effect, the Municipal Government of Taytay, Rizal shall provide a property for the site of the RPHS – Taytay Annex, free from any liens or encumbrances or whatever of the same kind, which in this case, is designating as property site the parcels of land covered by Tax Declaration Nos. 18-TY-002-08242 and 18-TY-001-12950;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby DESIGNATES AS THE PROPERTY SITE FOR THE CONSTRUCTION OF THE RIZAL PROVINCIAL HOSPITAL SYSTEM (RPHS) – TAYTAY ANNEX THE PARCELS OF LAND COVERED BY TAX DECLARATION NOS. 18-TY-002-08242 AND 18-TY-001-12950.



RESOLVED FURTHERMORE, that this Resolution will supersede Resolution Nos. 74 and 78, series of 2019.

RESOLVED FURTHERMOST, that copies of this Resolution be furnished to all concerned for their information, guidance and appropriate action.
