### RESOLUTION NO. 90 series of 2019

**A RESOLUTION ADOPTING REPUBLIC ACT NO. 11148, AN ACT SCALING UP THE NATIONAL AND LOCAL HEALTH AND NUTRITION PROGRAMS THROUGH A STRENGTHENED STRATEGY FOR MATERNAL, NEONATAL, CHILD HEALTH AND NUTRITION IN THE FIRST ONE THOUSAND (1,000) DAYS OF LIFE, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES, AT THE MUNICIPALITY OF TAYTAY, RIZAL**

WHEREAS, Republic Act No.11148, otherwise known as "Kalusugan at Nutrisyon ng Mag-Nanay Act", aims to address health and nutrition problems of newborns, infant and young children, pregnant and lactating women, adolescent females and all Filipino children who are newly born up to age 24 months;

WHEREAS, Section 17 of RA 7160, specifically mandates Local Government Units to provide basic health services which includes the implementation of programs and projects on primary health care and maternal and child care;

WHEREAS, the Local Government Units, under the Kalusugan at Nutrisyon ng Mag-Nanay Act are encouraged to integrate maternal, neonatal, child health and nutrition programs in the nutrition action plans and investment plans for health;


WHEREAS, to highlight the commitment of the Municipal Government of promoting public health and welfare, measures be adopted by the Sangguniang Bayan to ensure that national health objectives be translated into our local health policies and programs;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby ADOPTS REPUBLIC ACT NO.11148, AN ACT SCALING UP THE NATIONAL AND LOCAL HEALTH AND NUTRITION PROGRAMS THROUGH A STRENGTHENED STRATEGY FOR MATERNAL, NEONATAL, CHILD HEALTH AND NUTRITION IN THE FIRST ONE THOUSAND (1,000) DAYS OF LIFE, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES, AT THE MUNICIPALITY OF TAYTAY, RIZAL.


