### RESOLUTION NO. 98 series of 2019

**A RESOLUTION RESPECTFULLY REQUESTING RIZAL FIRST DISTRICT REPRESENTATIVE, HONORABLE CONGRESSMAN MICHAEL JOHN R. DUAVIT, TO AUTHOR A BILL DECLARING EVERY 3<sup>RD</sup> MONDAY OF FEBRUARY AS A SPECIAL NON-WORKING HOLIDAY FOR THE WHOLE MUNICIPALITY OF TAYTAY, RIZAL IN CELEBRATION OF THE HAMAKA FESTIVAL “ARAW NG PASASALAMAT”**

WHEREAS, the whole Municipality of Taytay traditionally celebrates the Araw ng Pasasalamat every third week of February to give thanks for the bountiful harvest for the past year and celebrate the week long HAMAKA Festival derived from the word HAMMOCK or duyan that even our National Hero, Dr. Jose Rizal would ride alongside his mother Teodora, from Taytay to Antipolo; the Festival promotes products and culture of Taytay; HA for Hamba, MA for Makina and KA for Kasuotan which made the Municipality earn the moniker as the Garments and Woodworks Capital of the Philippines;

WHEREAS, in 2018 Resolution No. 275 s. 2018 and Resolution No. 356 s. 2018 were adopted by the Sangguniang Bayan that paved the way for the issuance of Presidential Proclamation No. 419 dated February 7, 2018 and Presidential Proclamation No. 666 dated February 6, 2019 respectively by His Excellency President Rodrigo Roa Duterte thru Executive Secretary Salvador C. Medialdea declaring a Special Holiday for the whole Municipality of Taytay on February 19, 2018 and February 18, 2019;

WHEREAS, the Presidential Proclamation is only valid within the specific date stipulated in the declaration, wherefore, in order to have the aforementioned date perpetually declared as a Special Holiday for this Municipality, a Republic Act is imperative;


