A RESOLUTION IDENTIFYING THE PROPERTY THAT HAS BEEN MENTIONED IN RESOLUTION NO. 5 SERIES OF 2019 WHICH WAS OWNED BY SPOUSES DOMINADOR AND MARCELA V. DELA CRUZ LOCATED AT SITIO BUBUNSURAN, BARANGAY SAN ISIDRO, TAYTAY, RIZAL AND THE PROPERTIES NEARBY PARTICULARLY SITIO BAYABAS AND TAGUMPAY WILL NOT BE AFFECTED BY THIS PROJECT

WHEREAS, the Sangguniang Bayan of Taytay, Rizal adopted Resolution No. 5 series of 2019 entitled “A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HONORABLE MAYOR GEORGE RICARDO R. GACULA II TO NEGOTIATE AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH LOT OWNERS IN SITIO BUBUNSURAN AND RIZAL AVENUE, BARANGAY SAN ISIDRO, TAYTAY, RIZAL FOR THE PURPOSE OF RIGHT OF WAY OF SITIO TAGUMPAY AND SITIO BAYABAS AND FOR THE TRADE CENTER, SCHOOL AND HOUSING PROJECT FOR MUNICIPAL EMPLOYEES OF THIS MUNICIPALITY”;

WHEREAS, the properties subject for expropriation by the Municipal Government of Taytay, Rizal, with a total land area of 5,179 sq.m., covered with Tax Declaration No. 18-TY-001-12538 and TCT No. 604409, was owned and registered under the name of Spouses Dominador and Marcela V. Dela Cruz;

WHEREAS, the intention of the members of the Sanggunian Bayan on the said Resolution is for the benefit of the residents within and nearby areas of the said property so they can easily access to all those proposed projects by the Municipal Government;

WHEREAS, the said property will be use for the construction of the Taytay Municipal Government Annex and Event Center;


