### RESOLUTION NO. 122 series of 2019

**A RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF TAYTAY, REPRESENTED BY HON. GEORGE RICARDO R. GACULA II, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH ISOC INFRASTRUCTURE, INC. REPRESENTED BY JESUS G. CHUA, JR. TO BE THE ACCREDITED COMMON TOWER PROVIDER OF THE MUNICIPALITY**

WHEREAS, the President of the Philippines and the Department of Information and Communications Technology has approved the government-owned properties;

WHEREAS, the Sangguniang Bayan of the Municipal Government of Taytay is a legislative body duly organized according to law for the enactment of ordinances and the adoption of resolutions for the governance of the said immediately;

WHEREAS, the Sangguniang Bayan recognizes ISOC Infrastructure, Inc. ("ISOC"), a duly registered Philippine firm and infrastructure solutions provider, as the Municipality's preferred common tower provider;

WHEREAS, the Municipal Government of Taytay, Rizal and ISOC, seek to enter an agreement on the use of sites owned and controlled by the municipality for the common towers and in-building solutions in the public establishments, or the Common Tower Project ("Project");

WHEREAS, that the construction of the telecommunication towers according to the design specification required by the mobile network provider would address the current complaints about dead spots and slow drop calls commonly raised by network users;

WHEREAS, the telecommunication towers built would serve as the ground work for increasing the capacity and coverage of mobile network providers;

WHEREAS, the infrastructure and development projects would involve low cost to the Municipal Government of Taytay, Rizal;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE MUNICIPAL GOVERNMENT OF TAYTAY, REPRESENTED BY HON. GEORGE RICARDO R. GACULA II, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH ISOC INFRASTRURE, INC. REPRESENTED BY JESUS G. CHUA, JR. TO BE THE ACCREDITED COMMON TOWER PROVIDER OF THE MUNICIPALITY.

RESOLVED FURTHER, that the Memorandum of Agreement between the Municipal Government of Taytay, Rizal and ISOC shall be ratified first by the Sangguniang Bayan before its full implementation.


RESOLVED FURTHERMORE, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
