**APPROVING AND RATIFYING MUNICIPAL DISASTER RISK REDUCTION
AND MANAGEMENT COUNCIL (MDRRMC) RESOLUTION NO. 2018-04
APPROVING FY 2019 TAYTAY DISASTER RISK REDUCTION AND
MANAGEMENT PLAN (MDRRMP) IN THE AMOUNT OF FIFTY SIX MILLION
ONE HUNDRED FIFTY SEVEN THOUSAND THREE HUNDRED EIGHTY FIVE
PESOS (P56,157,385.00) FOR THE MUNICIPALITY OF TAYTAY, PROVINCE OF
RIZAL**

WHEREAS, Republic Act (RA) No. 10121 also known as Philippine Disaster Risk Reduction and Management Act of 2010 granted Local Government Units (LGUs) greater flexibility towards disaster mitigation, preparation, response, rehabilitation and recovery;

WHEREAS, Section 12 (a) of R.A. 10121 sates that Local Disaster Risk Reduction and Management Office (LDRRMO) shall be responsible for setting the direction, development, implementation and coordination of disaster risk management programs within their territorial jurisdiction; Section 12 (c) (6) The LDRRMO shall formulate and implement a comprehensive and integrated LDRRMP in accordance with the national, regional and provincial framework and policies on disaster risk reduction in close coordination with the Local Development Councils (LDCs); Section 12 (c) (7) Prepare and submit to the Local Sangguniang through the LDRRMC and the LDC the annual LDRRMO Plan and Budget, the proposed programming of the LDRRMF, other dedicated disaster risk reduction and

management resources, and other regular funding source/s and budgetary support of the LDRRMO;

WHEREAS, the Municipal Disaster Risk Reduction and Management Office (MDRRMO) through the Municipal Disaster Risk Reduction and Management Council (MDRRMC) in close coordination with the Municipal Development Council (MDC), submitted Municipal Disaster Risk Reduction and Management Council (MDRRMC) Resolution No. 2018-04 Approving FY 2019 Taytay Disaster Risk Reduction and Management Plan (MDRRMP) in the amount of Fifty Six Million One Hundred Fifty Seven Thousand Three Hundred Eighty Five Pesos (P56,157,385.00) for the Municipality of Taytay, Province of Rizal, for ratification;

WHEREAS, the amount appropriated for LDRRMF represents the five percent (5%) of the estimated revenue of the Municipality; of which thirty percent (30%) was allotted for Quick Response Fund (QRF) for Disaster Prevention and Mitigation, Preparedness, Response, Rehabilitation and Recovery;


WHEREAS, the Sangguniang Bayan finds the Municipal Disaster Risk Reduction and Management Plan (MDRRMP) and Municipal Disaster Risk Reduction and Management Fund (MDRRMF) in accordance with the provisions of the Local Government Code of 1991 or R.A. 7160 and R.A. 10121;

WHEREFORE, BE IT RESOLVED, as it is hereby resolved by the 10th Sangguniang Bayan of Taytay, Rizal in session duly assembled, hereby APPROVES AND RATIFIES MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC) RESOLUTION NO. 2018-04 APPROVING FY 2019 TAYTAY DISASTER RISK REDUCTION AND MANAGEMENT PLAN (MDRRMP) IN THE AMOUNT OF FIFTY SIX MILLION ONE HUNDRED FIFTY SEVEN THOUSAND THREE HUNDRED EIGHTY FIVE PESOS (P56,157,385.00) FOR THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL


RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action;
