SHORELAND DEVELOPMENT CLEARANCE FROM THE LAGUNA LAKE  
DEVELOPMENT AUTHORITY (LLDA) TO FACILITATE THE  
COMMENCEMENT OF THE PROJECT**

WHEREAS, the Provincial Planning and Development Office (PPDO) had requested the Sangguniang Bayan of Taytay to legislate a resolution of endorsement as a requirement on Shore land Development Clearance of Laguna Lake Development Authority;

WHEREAS, the said requirement is in connection with the Proposed Improvement of Taytay- Angono-Coastal Road Project funded by the Rizal Provincial Government, to be implemented on 1 Year 2019;

WHEREAS, during the deliberation it has been understood that the provincial funded project thereby will improved the present condition of coastal road, observing the proper elevation and considering the four lane way;

WHEREAS, the Taytay-Angono Coastal Road resolved the traffic congestion in the area of the Municipality of Taytay as a primary alternate route from C- 6 Floodway Road Highway to Angono and nearby municipalities like Binangonan, Cardona and onward;

WHEREAS, the 10<sup>th</sup> Sangguniang Bayan finds the legislated act worthy and beneficial to the constituents particularly the sectors of commuters riding public;



RESOLVED FURTHER, to send copies of the resolution to all concerned offices and agencies for their appropriate action and consideration;


