RESOLUTION APPROVING IN REVIEW DECLARING THE ANNUAL BUDGET OF BARANGAY SAN ISIDRO FY2019 IN THE AMOUNT OF PHP 38,319,634.00 UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 2018-001, OPERATIVE IN FULL, SUBJECT TO THE USUAL ACCOUNTING AND AUDITING RULES AND REGULATIONS

WHEREAS, the Annual Budget of Barangay San Isidro FY 2019 in the amount of Php 38,319,634.00 approved by the Sangguniang Barangay under Appropriation Ordinance No. 2018-001, was submitted for purpose of review pursuant to the provisions of R.A. 7160 otherwise known as the Local Government Code of 1991;

WHEREAS, the Annual Budget of Barangay San Isidro FY 2019 as submitted was initially reviewed and was declared INOPERATIVE IN PART, in SB Resolution No. 383 series 2019;

WHEREAS, upon further review by the Committee on Finance, Budget and Appropriations, Sangguniang Barangay of Barangay San Isidro had complied by submitting Brgy. Dev't. Council Resolution No. 1-2019, APPROPRIATING FUNDS REPRESENTING THE 20% DEVT FUND FOR CALENDAR YEAR 2019, and Brgy. Resolution No. 1-2019, RATIFYING THE BRGY. DEV'T COUNCIL RESO NO. 1-2019;

WHEREAS, the Brgy. San Isidro Sangguniang Kabataan had re-submitted their appropriation ordinance in compliance with the DBM, DILG & NYC Joint Memo Circular No. 1 series 2019;

WHEREFORE, BE IT RESOLVED, As It Is Hereby Resolved, by the 10th Sangguniang Bayan of Taytay, Rizal, In Session Duly Assembled, hereby **APPROVES IN REVIEW DECLARING THE ANNUAL BUDGET OF BARANGAY SAN ISIDRO FY2019 IN THE AMOUNT OF PHP 38,319,634.00 UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 2018-001, OPERATIVE IN FULL, SUBJECT TO THE USUAL ACCOUNTING AND AUDITING RULES AND REGULATIONS;**



RESOLVED FURTHERMORE, that this Resolution nullifies the previous approved Sangguniang Bayan Resolution 383, series of 2019;


RESOLVED FINALLY, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
