WHEREAS, the DONORS made the said donation without intent to defraud their creditors;


WHEREAS, the duly signed DEED OF DONATION shall be ratified by the Sangguniang Bayan before its full implementation;


RESOLVED FURTHER, that copy of this resolution be furnished to all concerned for their information and appropriate action.
