RESOLUTION NO. 145 series of 2020

A RESOLUTION PROMPTING THE BUSINESS PERMIT AND LICENSING OFFICE OF THE MUNICIPALITY OF TAYTAY TO SPOT CHECK ESTABLISHMENTS WITHIN TAYTAY THAT MAY TAKE ADVANTAGE OF THE INCIDENCES IN RELATION TO THE CURRENT TAAL VOLCANO ERUPTION

WHEREAS, Republic Act No. 7581 also known as THE PRICE ACT is AN ACT PROVIDING PROTECTION TO CONSUMERS BY STABILIZING THE PRICES OF BASIC NECESSITIES AND PRIME COMMODITIES AND BY PRESCRIBING MEASURES AGAINST UNDUE PRICE INCREASES DURING EMERGENCY SITUATIONS AND LIKE OCCASIONS;

WHEREAS, it is the policy of the State to ensure the availability of basic necessities and commodities at reasonable prices at all times without denying legitimate business a fair return on investment and it is also a declared policy of the State to provide effective protection to consumers against hoarding and profiteering of said goods, especially during periods of calamity, emergency, widespread illegal price manipulation and other similar situations;

WHEREAS, to ensure that those affected by the recent eruption of the Taal Volcano last January 12, 2020 and subsequent incidences are not taken advantage of by sellers, distributors and retailers who have been reported to be overpricing, it is but fitting for the BPLO to conduct spot checking of establishments, stores and the likes to prevent and curb such occurrences and implement existing laws and ordinances in relation to the aforementioned matter;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby PROMPTS THE BUSINESS PERMIT AND LICENSING OFFICE OF THE MUNICIPALITY OF TAYTAY TO SPOT CHECK ESTABLISHMENTS WITHIN TAYTAY THAT MAY TAKE ADVANTAGE OF THE INCIDENCES IN RELATION TO THE CURRENT TAAL VOLCANO ERUPTION.


RESOLVED FURTHER, that copies of this Resolution be furnished to the BPLO of this Municipality for their information and appropriate prompt action.
