RESOLUTION NO. 179 series of 2020

A RESOLUTION DECLARING UNDER THE STATE OF CALAMITY DUE TO PUBLIC HEALTH EMERGENCY BROUGHT BY THE SPREAD OF CORONA VIRUS DISEASE (COVID-19) IN THE ENTIRE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL

WHEREAS, on January 30, 2020, the World Health Organization declared the outbreak of Covid-19 disease as a public health emergency of International Concern after its escalation into an unprecedented outbreak in a global scale and that on the same day, the first case of COVID-19 in the Philippines was confirmed by the Secretary of Health;

WHEREAS, on March 8, 2020, President Rodrigo Roa Duterte issued Proclamation 922 declaring a State of Public Health Emergency;

WHEREAS, Section 2 of Proclamation No. 922 enjoined all government offices and LGU's to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent, and appropriate response and measures in a timely manner to curtail and eliminate the COVID-19 threat;

WHEREAS, on March 12, 2020, WHO characterized COVID-19 as pandemic and subsequently, a memorandum from the Office of the Executive Secretary was issued about Stringent Social Distancing Measures and further guidelines for the management of the Corona Virus Disease (COVID-19) Situation;

WHEREAS, on March 16, 2020, the Island of Luzon was placed under enhanced quarantine by the President Duterte effective 12:00 AM and expiring on 12:00 AM of April 13, 2020 and on the same day, a memorandum from the Executive Secretary was issued about the Community Quarantine for the entire Luzon and further guidelines for the management of the Corona Virus Disease (COVID-19) Situation;

WHEREAS, in order to mobilize and respond to the threat and control of possible outbreak, the declaration in the Municipality would capacitate the local and barangay units to immediately act to prevent loss of life, utilize appropriate resources to implement urgent and critical measures to contain or prevent the spread of COVID-19, mitigate it's effect and impact to the community, and prevent serious disruption of the functioning of the government and the community;

WHEREAS, all the Barangay Captains had reported all their situation in their respective Barangay, and upon clarification from the Municipal Health Officer and other concern agencies, it is imperative for us to declare the State of Calamity;

WHEREAS, because of the proximity of Taytay, Rizal and the gravity of COVID-19 situation, there is a clear and present danger that the same might spread into this Municipality;

WHEREAS, in particular, COVID-19 situation is a threat to the peace and order, security, lives and well being of every Taytayeños and its Local Government shall take every appropriate step, measures and preparedness in order to prevent, mitigate and control its spread to protect the health and lives of its people;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby declares UNDER THE STATE OF CALAMITY DUE TO PUBLIC HEALTH EMERGENCY BROUGHT BY THE SPREAD OF CORONA VIRUS DISEASE (COVID-19) IN THE ENTIRE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL;

RESOLVED FUTHER, that the Local Chief Executive is hereby authorizes to augment all items under the Quick Response Fund (QRF) of the Calamity Fund of the Municipality of Taytay;


RESOLVED FURTHERMORE, that all Local and Barangay instrumentalities of this Municipality are hereby enjoined to enforce all necessary law to maintain peace and order due to the outbreak of this COVID-19 to make sure that no one will take advantage of this situation. All profiteering and hoarding of necessary or basic needs of the people shall be held liable;

RESOLVED FURTHERMOST, that the declaration of the State of Calamity shall take effect until such time that the Proclamation 922 is lifted;

RESOLVED FINALLY, that this Resolution shall take effect immediately and copies be furnished to all concerned for their information and appropriate action;

ADOPTED, this 17th day of March, 2020 at the Sangguniang Bayan Session Hall, Municipality of Taytay, Province of Rizal.
