A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY THE MUNICIPALITY OF TAYTAY REPRESENTED BY THE MUNICIPAL MAYOR HON. GEORGE RICARDO R. GACULA II WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGION IV-A DULY REPRESENTED BY MS. LUCIA C. ALMEDA FOR THE SOCIAL AMELIORATION PROGRAM INTENDED FOR THE VULNERABLE SECTORS IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL

WHEREAS, the 11th Sangguniang Bayan had adopted Resolution 184, series of 2020 entitled a resolution authorizing the Municipal Mayor Hon. George Ricardo R. Gacula II to enter into a Memorandum of Agreement (MOA) in behalf of the Municipality of Taytay with the Department of Social Welfare and Development (DSWD) Region IV-A duly represented by Ms. Lucia C. Almeda for the Social Amelioration Program intended for the vulnerable sectors in the

Municipality of Taytay, Province of Rizal, and other programs related to COVID-19 augmentation response from the National Government;

WHEREAS, there is currently a Memorandum of Agreement between the Local Government of Taytay duly represented by the Hon. Mayor George Ricardo R. Gacula II and the Department of Social Welfare and Development Region IV-A, herein represented by Regional Director Ms. Lucia C. Almada regarding the Social Amelioration Program;

WHEREAS, the ratification of the Memorandum of Agreement will pave the way on the immediate processing of the financial assistance needed by the affected communities thereby lessening the burden brought by the present crisis;


