RESOLUTION NO. 189 series of 2020

A RESOLUTION RECOMMENDING TO THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE AND THE BARANGAYS TO PLACE ON LEAST PRIORITY LIST OF GOVERNMENT ASSISTANCE THOSE WHO WILL CAUSE THE DISRUPTION OF PUBLIC ORDER, THOSE WHO WILL BE CAUGHT VIOLATING THE TOTAL BAN ON ALL TYPES OF GAMBLING, VIOLATORS OF THE TOTAL LIQUOR BAN AND HABITUAL VIOLATORS OF THE CURFEW BEING IMPLEMENTED BASED ON ORDINANCE NO. 25 SERIES OF 2020 AND OTHER COVID-19 RELATED LAWS AND ORDINANCES

WHEREAS, under the Luzon-wide Enhanced Community Quarantine all types of gambling have been suspended, however different types of illegal gambling have been reported to occur in different parts of this Municipality;

WHEREAS, aside from committing unlawful acts in the midst of this crisis, instead of allocating their finances for purchasing food and other essentials for themselves and their families, some tend to divert it as bets for them to gamble;

WHEREAS, habitual violators of the curfew ordinance and other COVID-19 related Ordinances and Laws add to the risk of spreading the virus to those who are complying with the ECQ guidelines;

WHEREAS, with the government's limited funds and difficulty of acquiring supplies enough to cater to every residents, families and households, it would be fitting to prioritize and allocate such assistance to the benefit of those who are abiding by the policies of the National and Local Government in order to cope up with the COVID-19 pandemic;


WHEREAS, having the policy of placing on the least priority list of beneficiaries the families of would-be violators will instill responsibility among family members to remind their relatives that there are subsequent consequences if they continue to disregard laws and ordinances brought forth by the current situation;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby RECOMMENDS TO THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE AND THE BARANGAYS TO PLACE ON LEAST PRIORITY LIST OF GOVERNMENT ASSISTANCE THOSE WHO WILL CAUSE THE DISRUPTION OF PUBLIC ORDER, THOSE WHO WILL BE CAUGHT VIOLATING THE TOTAL BAN ON ALL TYPES OF GAMBLING, VIOLATORS OF THE TOTAL LIQUOR BAN AND HABITUAL VIOLATORS OF THE CURFEW BEING IMPLEMENTED BASED ON ORDINANCE NO. 25 SERIES OF 2020 AND OTHER COVID-19 RELATED LAWS AND ORDINANCES.

RESOLVED FURTHER, that all implementing agencies shall from time to time immediately furnish the MSWDO and all Barangays the list of apprehended individuals for references.
